Ordinance No. 1-16

**AN ORDINANCE AMENDING CHAPTER 15, SECTION 409
OF THE CODE OF THE BOROUGH OF MILLERSBURG PROVIDING FOR
TRANSFERABLE PARKING PERMITS IN METERED PARKING SPACES**

WHEREAS, the current Borough Ordinance allows residents and business owners to purchase permits allowing those individuals to park vehicles in metered parking spaces without paying the usual parking meter fees; and

WHEREAS, the Ordinance requires that each parking permit be assigned to a specific vehicle; and

WHEREAS, the Borough Council has identified certain circumstances in which it is appropriate to allow the transfer of a parking permit to different vehicles; and

WHEREAS the Borough Council, acting on advice of the Solicitor, wishes to allow permit holders to transfer parking permits among vehicles.

THEREFORE BE IT ENACTED AND ORDAINED by the Borough Council of Millersburg Borough, Dauphin County, Pennsylvania as follows:

1. In §15-409, Subsection 5, the phrase “who shall be the only owner or driver of a motor vehicle” and the sentence reading “Each Application shall contain the following information: the name of the owner or driver, as the case may be, of the motor vehicle; the address of the resident or proprietor, as the case may be; the make, model and registration number of the motor vehicle; and the driver number as taken from the applicant’s current driver’s license” are repealed.
2. The following language is inserted into §15-409, Subsection 5: “The Millersburg Police Department shall create an application for a parking permit and require such information as the department deems necessary to fulfill the letter and intent of this Ordinance. No more than one (1) permit shall be issued to the resident of a home and no more than two (2) permits shall be issued to the proprietor of any single business. Home-based businesses are counted as a ‘resident’ for purposes of these limits.”
3. The following phrase is repealed in §15-409, Subsection 6: “the serial and registration numbers of the motor vehicles.”
4. The language contained in §15-409, Subsection 8, C is hereby amended to read as follows: “The permit shall be assigned to a resident or proprietor of a residence or business located in the area referenced in §15-409. The permit shall be clearly visible from the

location of the parking meter at the space in which the vehicle is parked. In the event that a resident or proprietor no longer owns or leases a building in the referenced area, the permit shall be rendered invalid. The holder is entitled to all fees paid, prorated to the final day of residence or operation of the business.”
