BOROUGH OF MILLERSBURG DAUPHIN COUNTY

Amendment to the Motor Vehicle and Traffic Ordinance Located in Chapter 15 of the Code of the Borough of Millersburg

Ordinance No. 1-06

BE IT ENACTED AND ORDAINED by the Council members of Millersburg Borough, Dauphin County, Pennsylvania, as follows:

SECTION 1 - Purpose

The purpose of this Ordinance is to amend various sections of Chapter 15, Part 4, Sections 402 and 406 of the Motor Vehicle and Traffic Ordinance of Millersburg Borough. The enactment of these amendments to the existing ordinances have been determined by the Millersburg Borough Council to be a benefit to the health, safety and welfare of the residents of Millersburg Borough.

SECTION 2 - List of Amendments

The following is a list of amendments to the existing ordinance:

- 1. Chapter 15, Part 4, Section 402, Subsection, is hereby amended by the addition of the following: Ridgewood Drive, south side, eighty (80) feet from the stop sign; No Parking Here to Corner.
- 2. Chapter 15, Part 4, Section 402, Subsection, is hereby repealed in part as follows: Walnut Street, west side between Union Street and Herman Street; No Parking.
- Chapter 15, Part 4, Section 402, Subsection, is hereby amended by the addition of the following: Walnut Street, west side between Union Street and North Street; No Parking.
- 4. Chapter 15, Part 4, Section 406, Subsection, is hereby amended by the addition of the following: Walnut Street, west side between North Street and Herman Street, Monday through Friday 6:00 A.M. to 6:00 P.M.; No Parking.
- 5. Chapter 15, Part 4, Section 402, Subsection, is hereby amended by the addition of the following: Walborn Lane, west side, one hundred forty (140) feet north of Wert Street for a distance of sixteen (16) feet; No Parking.

Chapter 15, Part 4, Section 402, Subsection, is hereby amended by the addition of the 6. following: West Union Street, two hundred twenty-six (226) feet west of West Street, south side of West Union Street, from south side diagonally to north side beyond the line; No Parking.

SECTION 3 - Repeal

All ordinances or resolutions or parts of ordinances or resolutions, insofar as they are inconsistent herewith, be and the same are hereby repealed.

SECTION 4 - Effective Date

This ordinance shall become effective five (5) days after its adoption.
