PART 1

GENERAL REGULATIONS

§3-101. Definitions.

The word "street," as used in this Part only, shall include public highways, boulevards, avenues, alleys and all other Borough property, parks, sidewalks and other accessible property which would be considered public property; and the word "vehicle" as used in this Part shall include bicycles, skateboards, roller skates, roller blades or similar wheeled devices, sleds, toboggans, saucers or similar equipment used for sliding, guiding or coasting.

§3-102. License or Registration.

The Millersburg Borough Council, through resolution, may at some future time, adopt regulations regarding the licensing and registering of vehicles (as defined in this Part). Said regulations may include a license fee for registration and such fee may be fixed, from time to time, by the Millersburg Borough Council.

§3-103. Reckless Operation Prohibited; Number of Passengers; Sidewalk Riding Prohibited.

It shall be unlawful for any person to operate a vehicle (as defined in this Part) in the Borough in a manner which could cause bodily injury to the rider of the vehicle or pedestrian, or in any reckless manner. It shall be unlawful for any operator of any vehicle to cling to any other moving vehicle in the Borough. It shall be unlawful for any person to operate a vehicle (as defined in this Part) upon sidewalks in the Borough on Market Street from Pine Street to Moore Street, and on Union Street from West Street to Race Street, including Market Square Park, and on Center Street from Market Street to Walnut Street and Walnut Street from Union Street to Center Street.

§3-104. Light and Reflector Required for Night Riding.

It shall be unlawful for any person to operate any vehicle in the Borough which may violate the Pennsylvania Vehicle Code.

§3-105. Interference with Pedestrians Prohibited.

It shall be unlawful for any person to operate a vehicle in such a manner as to interfere with any pedestrian or to allow such a vehicle (as defined in this Part) to obstruct pedestrian traffic.

§3-106. Impoundment Procedures.

If the operator of any vehicle (as defined by this Part) shall violate any provision of this Part, such vehicle may be immediately taken and impounded by the Police Department of the Borough, and may be so held by such Department for a period not exceeding 7 days to be determined by the Chief of Police.

§3-107. Penalty for Violation.

Any person who shall violate any provision of this Part shall, upon conviction thereof, be sentenced as follows:

- A. First Offense. Thirty day confiscation. All vehicles confiscated from persons under the age of 18 years shall be returned to said person's parent or guardian.
- B. Second Offense. Permanent confiscation.
- C. Third Offense. Violator shall pay a fine of not less than \$25 nor more than \$600 plus costs, the vehicles shall be permanently confiscated, and in default of payment of said fine and costs, to a term of imprisonment not to exceed 30 days. Each day that a violation continues shall constitute a separate offense. [A.O.]
