2-1953	1/16/1953	Specifying an additional project to be undertaken by Millersburg Borough Authority. This authorized the construction or acquisition of a sewer system in addition to the water supply system.
4-1953	9/18/1953	Extending Social Security benefits to Borough employees.
6-1980	12/11/1980	Suspending contributions to the Borough's Police Pension Fund for 1 year on adoption date of this ordinance.
1-1981	5/14/1980	Authorizing the Borough to join with other local government units as a settlor of the Pennsylvania Local Government Investment Trust for the purpose of purchasing shares of the Trust.
3-1981	12/29/1981	Amending that member contributions to the police pension plan shall be suspended for 1 year when the fund continues as sound without member contributions.
3-1982	12/30/1982	Amending that member contributions to the police pension plan shall be suspended for 1 year when the fund continues as sound without member contributions.
Res. 4/14/1983		Designating the Upper Dauphin Industrial Development Authority as hearing agency on behalf of the Borough for approval of projects financed by issuance of bonds.
Res. 10/13/1983		Designating the Upper Dauphin Income Tax Office as delinquent tax collector and empowers to take whatever action it deems necessary to collect any delinquent taxes referred to it by the Borough.
