

**MILLERSBURG BOROUGH
DAUPHIN COUNTY, PENNSYLVANIA**

ORDINANCE NO. 4-12

**Amendment to the Motor Vehicle and Traffic Ordinance
Located in Chapter 15 of the Code of the Borough of Millersburg**

BE IT ENACTED AND ORDAINED by the Council members of Millersburg Borough, Dauphin County, Pennsylvania, as follows:

SECTION 1 – Purpose

The purpose of this Ordinance is to amend Chapter 15 and various parts and sections of the Motor Vehicle and Traffic Ordinance of Millersburg Borough. The enactment of this Amendment to the existing Ordinance has been determined by the Millersburg Borough Council to be for the benefit of the residents of Millersburg Borough.

SECTION 2 – Amendment

Chapter 15 and various parts and sections are hereby amended to read as follows:

- A. Millersburg Borough Council previously adopted Resolution 12-09 creating a 90-day trial period for erecting traffic control devices in the vicinity of what is known as the RML Warehouse; and as a result of that trial period, it is determined to be in the best interest of the residents of Millersburg Borough to amend Chapter 15 and various parts and sections of the Motor Vehicle and Traffic Ordinance of Millersburg Borough to provide for the following traffic control devices and regulation:

Corner of Plum and Race Streets

Stop sign for eastbound traffic
Stop sign for westbound traffic

Corner of Race and Pine Streets

Stop sign for southbound traffic
Trucks: No turns for both northbound and southbound traffic
Trucks: No right turns for eastbound traffic

Corner of Short and Plum Streets

Stop sign for northbound traffic

Chestnut Street between Race and Short Street

No parking this street on the south side

No parking this street on the north side

Corner of Pine and Short Streets

No thru traffic

No parking/loading zone 8:00 a.m. to 5:00 p.m.

Corner of Chestnut and Short Streets

Stop sign for southbound traffic

No thru traffic

No parking/loading zone 8:00 a.m. to 5:00 p.m.

Chestnut Street from Race to Church Streets

Speed limit 10 mph

Truck crossing

Race, Pine and Plum Streets

No truck parking

Chestnut Street

No parking this street on the south side

Designate truck parking only on north side between Short and Church Streets

Race and Pine Streets

Truck crossing signs

Corner of Chestnut and Short Streets

Convex mirror

Chestnut and Church Streets

Convex mirror

For the purpose of this Amendment a truck is defined as any vehicle over 30 feet long with 4 or more axles.

B. Millersburg Borough Council also provides for the following traffic control device and regulation:

Oak Street between Blosser Street and Church Street

No parking this street on the north side

SECTION 3 – Violations

Any person who violates the parking prohibitions and traffic controls set forth herein shall be penalized in accordance with Chapter 15, Part 4, Section 411 and amendments thereto.

SECTION 4 – Repeal

All ordinances or resolutions or parts of ordinances or resolutions insofar as they are inconsistent herewith, be and the same are hereby repealed.

SECTION 5 – Effective Date

This Ordinance shall become effective October 10, 2012.
