**ORDINANCE NO. 3-18**

**AN ORDINANCE ESTABLISHING COMPACT CAR PARKING  
AT CERTAIN LOCATIONS WITHIN MILLERSBURG BOROUGH**

**WHEREAS**, the Borough of Millersburg owns, maintains and enforces parking meters at various locations within the downtown area; and

**WHEREAS**, oversized vehicles can obstruct lines of sight at intersections, creating safety concerns; and

**WHEREAS**, the Borough Code of the Commonwealth of Pennsylvania, Pennsylvania Vehicle Code (Title 75, Section 3353), and the Code of the Borough of Millersburg allow the Borough Council to regulate parking on public streets; and

**WHEREAS**, the referenced parking restriction is recommended by a traffic study performed by the Pennsylvania Local Technical Assistance Program (LTAP) and received by Millersburg Borough on April 25, 2018;

**WHEREAS**, Title 67, Chapter 212, Section 212.114 of the Pennsylvania Code specifically permits local authorities to prohibit parking of certain kinds or classes of vehicles;

**THEREFORE BE IT ENACTED AND ORDAINED AS FOLLOWS:**

1. It shall be unlawful to park any vehicle other than a subcompact car, a compact car or a motorcycle at the first two angled parking spaces at the following locations:
  - i. Northwest corner of Center and Market
  - ii. Southwest corner of Center and Market
  - iii. Southwest corner of North and Market
  - iv. Southeast corner of North and Market
  - v. Northeast corner of Market Square and Market
2. It shall be unlawful to park any vehicle other than a subcompact car, compact car or a motorcycle at the first non-metered parking space on the northeast corner of Market Street and Pine Street.
3. The terms "subcompact car" and "compact car" are defined using the current definition used by the US Environmental Protection Agency.
4. Signs detailing the parking restriction shall be posted at each parking space in compliance with Title 67, Chapter 212, Section 212.114 of the Pennsylvania Code.
5. The penalty for a violation of this Ordinance shall be a fine of not less than \$15. If, in the opinion of the Millersburg Borough Police Department, a vehicle parked in violation of this Ordinance presents an immediate safety hazard, a police officer may have the vehicle towed and the owner shall be responsible for all associated fees.
